This registration is signed on 31, May, 2025 which represents a registration of Future Generations Afghanistan) with the Ministry of Public Health. This document is not NOC or MoU. All NGOs must obtain NOCs or permission from MoPH prior to the implementation of the health project.

This umbrella registration does not replace the official NGO registration system of the Ministry of Economy and is not related to any specific project proposal which requires formal, separate approval of the Ministry of Public Health. Its purpose is to outline major principles to be followed by all agencies delivering health care in Afghanistan and needs only to be signed by each agency once every year.

Organization's general objectives: Future Generations Afghanistan teaches and enables a process for equitable community change that integrates environmental conservation with social development.

Organization's objectives in Afghanistan: A three way partnership and cooperation among communities, Government, NGOs & academic institutions to address communities access to sources and public services.

Organization's Mission: Facilitate the process of equal social change for empowerment of communities societies specially youths and teenagers in cooperation with Government entities and social organizations to enable them to shape their futures.

Organization's Vision: To strengthen the resourcefulness of communities, ensure community ownership, and promote partnership with government for a secure, equitable, and sustainable future.

This registration obliges both parties to respect the following principles:

- 1- The registration is valid for one year and extendable in case there is no complaint against the NGO and no violation by the NGO in implementing projects in the health sector.
- 2- **This document does not serve as a permission for NGOs to perform health activities. All NGOs must obtain permission/NOC from the MoPH and sign MoU with the MoPH before the implementation of their health project.**
- 3- The NGO shall officially consult with the Ministry of Public Health about the selection of site before the implementation of any health project. It should sign MoU with the Ministry of Public Health prior to the project implementation so the provision of services is fully legal. Failure to do so will cause disruption in their registration/renewal of registration.
- 4- Based on this registration, the NGOs cannot perform the health activity prior to signing MoU between MoPH and NGOs.
- 5- Agency will deliver all components outlined in the Basic Package of Health Services (BPHS) and/or Essential Package of Hospital Services (EPHS) after obtaining the NOC and signing MoU with the Ministry.
- 6- If an NGO delivers a vertical program or focuses on certain components of BPHS/EPHS, they must obtain official permission from the leadership of the MoPH.
- 7- Agency will follow all health policies of the MoPH.
- 8- Agency will comply in reporting data and information based on the MoPH HMIS and standards.
- 9- Agency will participate in coordination mechanisms at the central and provincial levels.
- 10- Project information including staffing, salary scale and budgets will be made available to MoPH in a timely manner upon request.
- 11- Agency will agree to participate in the national monitoring and evaluation system operated by MoPH and a third party.
- 12- Agency staff will conduct themselves and implement their projects in a manner that is culturally appropriate.
- 13- Agency will keep the number of the expatriate staff to the minimum required; based on needs and competency.
- 14- Agency will contribute towards training relevant Afghan staff based on a training need assessment for future sustainability.
- 15- The MoPH has the right to monitor & evaluate the agencies project activities at any time during the duration of this registration.
- 16- MoPH and agency will respect the principles of equity, efficiency and non-discrimination on the basis of ethnicity, gender or any other factor outlined in the National Development Budget Narrative and National Health Strategy.
- 17- In addition, under-served areas should be prioritized for service delivery even if these areas present more difficulties logistically.
- 18- MoPH and agency agree to work together in a collaborative and transparent partnership that is characterized by mutual respect.

19- Any disputes will be resolved through discussion with Provincial Health Coordination Committee (PHCC) or central MoPH representatives. MoPH reserves the right to appoint a third party to assist in resolving any disputes.

20- The MoPH has the right to terminate this registration at any time for non-compliance with any of the above provisions of this registration.

21- NGO shall observe and implement the principles and laws of the Islamic Emirate of Afghanistan.
